The Price Control and Anti-Profiteering (Mechanism to Determine Unreasonably High Profit for Goods) Regulations 2016 is introduced EFFECTIVE JANUARY 1, 2017. The regulation covers ALL food and beverages and non-durable household goods and personal care excluding cosmetics.
