

# FMM Trade & Investment Mission to Jakarta, Indonesia April 4 — 6, 2017

## JAKARTA, INDONESIA

Indonesia, with a total population of 255 million people is Malaysia's seventh largest trading partner and the third largest among ASEAN countries. Total trade between Malaysia and Indonesia rose by 0.8% from RM59.7 billion in 2014 to RM60.2 billion in 2015. Malaysia's investment in Indonesia accounted for about RM60 billion in 2015 mainly in key sectors such as oil palm plantation sector, banking, oil and gas, telecommunications and construction. Trade and investment opportunities offered by the Indonesia include manufacturing in metals, chemicals, electronics and machinery, infrastructure, agriculture and maritime industry.

- To enhance and promote business opportunities and partnership between Malaysian and Indonesian businessmen;
- To explore and pursue export opportunities in Indonesia including joint ventures, distributorship; and
- To provide insights on doing business in Indonesia through meetings/discussions with the relevant government authorities and investment board.
