- **Bachelor's Degree** in any discipline **and** at least **1 year** working experience in *Quality related field*, or
- **Diploma** in any discipline **and** at least **2 years** working experience in *Quality related field*, or
- **Certificate** in any discipline **and** at least **3 years** working experience in *Quality related field*, or
- **Minimum SPM / MCE / SPVM** qualification **and** at least **4 years** working experience in *Quality related field*
