INTRODUCTION

Effective April 1, 2017, Malaysia has abolished the Customs Duty (PDK) and adopt the ASEAN Harmonised Tariff Nomenclature (AHTN). This will involve a total change of Customs HS Code from the current HS 9-digit to HS Code 10-digit.

The new HS Codes includes 233 sets of amendments namely agricultural, chemical, wood, textile, base metal, machinery, transport and other sector.

To update industries on the implementation of the new HS Codes 2017, FMM Eastern has taken the initiative to collaborate with the officials from Royal Malaysian Customs Department Putrajaya to organize this seminar to ensure all the manufactures comply with the updates.
