| 1  | <p><b><u>National Employment Council</u></b></p> <p>a. FMM carried out a data collection exercise with MITI on the employment trends for 2021 from 283 member companies nationwide from March 8 – 12, 2021. The data of these companies have been shared with SOCSO to assist the companies in filling their vacancies from the database of jobseekers who have registered on the MyFutureJobs portal.</p> <p>b. SOCSO collaborated with FMM and organised a Job Fair for FMM members on April 7, 2021 at KLCC which was participated by 31 FMM member companies (offering a total of 1896 vacancies). | 2  | <p><b><u>Act 446</u></b></p> <p>FMM submitted its request to meet with YB Minister of Human Resources to discuss implementation issues with Act 446 on April 2, 2021. The letter highlighted the challenges faced in meeting some of the requirements immediately in order to obtain the Certificate for Accommodation and FMM's recommendations to address some of the pressing issues towards facilitating compliance.
