in foreign parties interested in supplying above stated Raw material for the
purpose of manufacturing high quality edible Coconut Oil**

Objective

The high quality product will be used for the local consumer market with an intention to safeguard the brand image of Coconut oil.

Methodology in selection of the Supplier :

The most competitive price quoted bidder will be selected who is willing to comply with the specified quality standards and tender conditions.

Eligibility :

Foreign based manufacturers, their authorized local agents, traders or exporters are eligible to submit their tenders to supply the required raw material quantity.

The supplier should be willing to abide by the tender terms and conditions.

The successful bidder should agree to supply the total quantity requirement of 39000. metric tons within a period of 180 days.

Partial shipments are allowed for a minimum of 1500 Metric tons per single shipment.

The expertise and past export history of the exporter's ability to provide a bid bond will be considered for the selection.

Procedure for submitting your EOI/ BID :

Your sealed quotation should be sent on or before 12th March 2021 at 13.00hrs by hand, registered post or international courier to the Committee Chairman, BCC Lanka Ltd. Hultsdorf Mills, PO Box No. 281, Meeraniya Street, Colombo 12.

When submitting EOI/ Quotation reference BCC/2021/DCC/1 should be quoted on the top left side of the sealed document and the size of the document should not exceed A4 size to be deposited into BCC Lanka Limited - TENDER deposit Box.

Quotations or tenders will not be accepted by email or fax.

All tenders will be opened on 12th March 2021 at 14.30 hrs by the Tender Technical Committee.

The successful bidder should furnish a bid bond of 2% for the bid total shipment value in the form of a Bank Guarantee valid for 90 days from an accepted bank to the credit of BCC Lanka Ltd. The bond will be released after goods are successfully delivered and accepted by the Importer.

The consignee (beneficiary) of the cargo will be BCC Lanka Ltd as per the postal address stated above.
