Following the strong efforts by the Ministry of International Trade and Industry (MITI) in completing the domestic procedures and with the mandate received from the Cabinet to enable the submission of Malaysia's Instrument of Ratification (IOR) for the CPTPP with the depositary in New Zealand on September 30, 2022, the **CPTPP will enter into force for Malaysia on November 29, 2022.**

Why You Should Attend?

- 100% of Malaysian exports to **Australia** and **Singapore** will enjoy zero duties;
- Key Malaysian exports such as automotive parts and components, plastics products, surgical gloves, rubber products, textiles and clothing, cocoa products and food items to **Canada** and **Mexico** which currently range from 15%-30% will be eliminated immediately;
- Significant reductions in import duties for processed food and beverages for exports to **Canada, Mexico, Japan** and **Peru**; and
- Immediate access to the Government Procurement (GP) markets of other CPTPP countries at much lower thresholds, as compared
