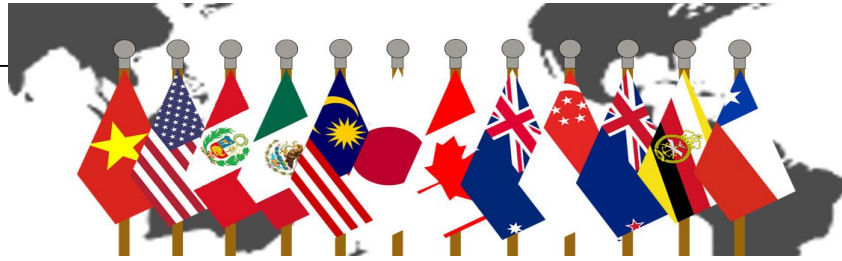




The Trans Pacific Partnership (TPP) and Future FTAs:
