Stamp Duty Self-Assessment System (SDSAS)

The stamp duty self-assessment will come into effect in phases, commencing 1 January 2026. With the implementation, taxpayers will be required to independently calculate and pay stamp duty based on the type of instruments or agreement. Failure to comply or make a correct return will be liable to fines and penalties, following the amended Stamp Act.

Key Updates on SDSAS

Currently, stamp duty is assessed by the Inland Revenue Board of Malaysia (IRBM) based on the executed instruments/agreements and information entered into the Stamp Assessment and Payment System (STAMPS) with payments made according to IRBM's notice of assessment. Under SDSAS, taxpayers or appointed agents must submit stamp duty return together with the executed instruments/agreements and required information electronically, self-assess the applicable stamp duty and make payments within a specified timeframe.

Phased implementation:

- Phase 1 (2026) : Rentals, leases, general stamping and securities
- Phase 2 (2027) : Property ownership transfers
- Phase 3 (2028) : Other instruments and agreements

This transition is intended to improve efficiency, streamline the stamping process and enhance compliance.

With the phased implementation set to commence soon, it is crucial for all taxpayers to be well-prepared and thoroughly understand the requirement to ensure compliance and avoid financial and operational disruptions as well as penalties.
