



Workshop on Understanding Free Trade Agreements and Complying with Rules of Origin with Latest Updates

Malaysia has signed 16 Free Trade Agreements (FTAs), of which 7 are bilateral agreements and the remaining 9 are regional FTAs. Last year, Malaysia's trade with FTA partners accounts for 66.7% or RM1.185 trillion. All 7 bilateral FTAs (Australia, Chile, India, Japan, New Zealand, Pakistan and Turkey) have been implemented and entered into force. Amongst the 9 regional FTAs that have been signed by Malaysia, 7 have entered into force through the Association of Southeast Asia Nations (ASEAN) FTAs with Australia and New Zealand, the People's Republic of China, Hong Kong, India, Japan and South Korea.
