Endorsement of FMM Non-Preferential Certificate of Origin (NPCO)

December 20, 2022; Tuesday 9:30 am – 11:30 am Remote Online via Zoom



Increasingly, more countries are requiring importers to produce certificates of origin (CO) to establish the country of origin of these imports. Hence very often, one of the crucial terms and conditions of the LC or business contracts would be for the exporter to secure a CO duly endorsed by a trade association. Failure to comply with the expressed requirement of the buyer may result in the exporter facing possible payment problems or the imported consignment facing Customs clearance difficulties.

FMM, being a member of the National Chamber of Commerce in Malaysia as well as the International Chamber of Commerce, Paris, has been issuing NPCOs for many years. Our record shows that many countries have found the CO issued by FMM is reliable and acceptable.

FMM Perak is organizing a briefing on the application and endorsement of the FMM NPCOs for the benefit of Perak industries which need NPCOs for their exports. This briefing is part of our efforts to assist exporters to understand better the process and requirements in NPCO application and thus ensure that your goods arrive at the country of destination without any problems.
