## INTRODUCTION

Corporate Liability Provisions would come into **effect on June 1, 2020** under New Section 17A Malaysian Anti-Corruption Commission (Amendment) Act 2018.

- The Provisions are similar to the UK Bribery Act 2010 and US Foreign Corrupt Practices Act 1977 which **hold a commercial organisation liable for their employees and/or associates' corrupt practices carried out for the organisation's benefit or advantage.** Once the offence is committed by the commercial organisation, the law will deem the directors, controllers, person whom are in the management of affairs within commercial organisation to have also committed that offence
- Penalties, upon conviction, may entail a **fine ten (10) times the value of gratification or RM 1 million**, whichever is higher. And/or a **jail sentence not exceeding 20 years**
