## Application for Ordinary Membership

### Eligibility

Any company, partnership or sole proprietor, carrying on business as a manufacturer in Malaysia is eligible to become an **Ordinary Member** of the Federation of Malaysian Manufacturers.

### Entrance Fee and Subscription

An Ordinary Member has to pay an Entrance Fee of RM500/-.

The annual subscription fee is dependent on the company's issued capital and may vary when the issued capital changes. The scale is as follows:
